**COMPLAINT**

Comes now ROSE HEMBROOK represented by attorneys BRAZIL CLARK, PLLC, and for her complaint would show:

**PRELIMINARY STATEMENT**

1. This is a claim for relief pursuant to 42 U.S.C. §1983 for False Arrest in violation the Fourth Amendment to the United States Constitution and Malicious Prosecution in violation of the Fourth Amendment to the United States Constitution, made applicable to the State of Tennessee and those acting under color of state law by the Fourteenth Amendment to the United States Constitution.

**JURISDICTION**

2. This Court has original jurisdiction pursuant to 28 U.S.C. §§ 1331 and 1343(a)(3)-(4) because this civil action is brought for the redress of deprivations of constitutional rights protected by 42 U.S.C. § 1983 and the Fourth and Fourteenth Amendments to the United States Constitution.

### VENUE

3. Venue is proper in this Court under 28 U.S.C. § 1391(b)(1) because the Defendant resides in this judicial district.

### PARTIES

4. Plaintiff Rose Hembrook (hereinafter referred to as “Plaintiff”) is a longtime resident in the city of Pikesville, located in Bledsoe County, Tennessee.
5. Defendant Donald Seiber, (hereinafter referred to as “Detective Seiber”) is a Trooper for the Tennessee State Highway Patrol, and is a citizen and resident of Cumberland County, Tennessee. Defendant is being sued solely in his individual capacity.

### FACTS

6. Ms. Hembrook is a longtime resident of Bledsoe County, Tennessee, where she operated a hemp farm in 2019.
7. On August 14, 2019, The Tennessee Department of Agriculture issued a hemp producer license to Ms. Hembrook pursuant to Tenn. Code Ann. § 43-27-102 (West 2019). (**Exhibit 1**).
8. On September 27, 2019, after a harvest, Ms. Hembrook cleaned up the dead leaves and other hemp refuse and collected the debris into garbage bags.
9. Plaintiff loaded two garbage bags of hemp debris into the trunk of her car to be taken to the dump for disposal.

10. Before hauling away hemp refuse, out of an abundance of caution, Ms. Hembrook obtained a Hemp Movement Permit (**Exhibit 2**) from the Dept. of Agriculture.
11. The permit, valid for September 27, 2019, authorized travel with rooted hemp from Ms. Hembrook's farm in Pikeville, TN to the trash dump in Pikeville, TN.<sup>1</sup>
12. The permit listed the Ms. Hembrook as an authorized party, along with her driver's license number and vehicle.
13. As she traveled to the dump on September 27, 2019, Trooper Seiber initiated a traffic stop for a seatbelt violation.
14. As he approached her vehicle, Trooper Seiber smelled the odor of cannabis.
15. Hemp and marijuana smell the same and are indistinguishable based upon smell alone. (See Cynthia A. Sherwood, Davis F. Griffin & Alexander H. Mills, Even Dogs Can't Smell the Difference the Death of 'Plain Smell,' As Hemp Is Legalized, Tenn. B.J., December 2019, at 14, 15 (2019)).
16. Trooper Seiber noticed that Ms. Hembrook had hemp debris on her shirt and noticed the two garbage bags in her car.
17. Ms. Hembrook informed Trooper Seiber that she was hauling hemp debris and trash to the local dump.
18. Trooper Seiber searched Ms. Hembrook's car and opened the two trash bags filled with hemp debris.

<sup>1</sup> Because the hemp Ms. Hembrook carried in her vehicle was not "rooted" hemp, a movement permit was not actually required. Tenn. Code Ann. § 43-27-103 (West 2020).

19. Ms. Hembrook showed Officer Seiber her Tennessee Department of Agriculture Hemp License, Hemp Movement permit, and six certificates of analysis from a private lab (**Exhibit 3 – Lab Certificates of Analysis**) These documents presented overwhelming evidence demonstrating the lawfulness of Ms. Hembrook's conduct.
20. During the traffic stop, two local County Sherriff's Deputies arrived. The deputies explained that Ms. Hembrook's farm had been investigated and was compliant with all Tennessee Department of Agriculture State Regulations.
21. The two deputies further stated that the substance in Ms. Hembrook's garbage bags was indeed hemp.
22. Trooper Seiber failed to examine and willfully ignored the readily available exculpatory evidence presented by both Ms. Hembrook and the two sheriff's deputies.
23. The exculpatory evidence provided to Trooper Seiber defeats any probable cause he had to arrest Ms. Hembrook.
24. Despite the evidence which Ms. Hembrook provided the Defendant and the statements by the deputies, Trooper Seiber charged Ms. Hembrook with felony Possession of Marijuana with Intent to Distribute/Sell/Manufacture in violation of Tenn. Code Ann. 39-17-417. (**Exhibit 4**).
25. Trooper Seiber knew or should have known that he lacked probable cause to support these charges, particularly when he was provided with



- paperwork from Ms. Hembrook and statements from two separate sheriff's deputies all stating that the substance in Ms. Hembrook's car was indeed hemp.
26. Prior to September 27, 2019, Ms. Hembrook was employed with the Upper Cumberland Human Resource Agency ("UCHRA") in Crossville, Tennessee and with Home Health Care.
  27. As a result of the felony charge initiated by Trooper Seiber, Ms. Hembrook was terminated from her job with UCHRA.
  28. On October 7, 2019, Plaintiff appeared at a hearing for the charges brought against her.
  29. At this court appearance, the prosecuting attorney requested an analysis from the Tennessee Bureau of Investigation of Ms. Hembrook's hemp.
  30. The analysis demonstrated again that the substance seized from Ms. Hembrook's vehicle on September 27, 2019, was indeed hemp.
  31. On March 6, 2020, at 2:50 p.m., Trooper Seiber pulled over Ms. Hembrook's vehicle without probable cause to believe that any crime had been committed.
  32. Trooper Seiber performed this stop purely to harass and intimidate Ms. Hembrook. He had no reasonable articulable suspicion to initiate the traffic stop.

33. Fearing for her safety and knowing that there existed no legal basis for Trooper Seiber's actions, Ms. Hembrook ran into a parking lot on foot while shouting for help.
34. Trooper Seiber charged Ms. Hembrook with Evading Arrest, Resisting Arrest and Disorderly conduct and placed her under arrest.
35. Trooper Seiber knew or should have known that there was no probable cause to charge Ms. Hembrook with Evading Arrest, Resisting Arrest, or Disorderly Conduct.
36. On March 18, 2020, the Tennessee Bureau of Investigation returned an Official Forensic Chemistry Report to Trooper Seiber stating that the substance in Plaintiff's car on September 27, 2019 was hemp.
37. On April 6, 2020, Ms. Hembrook appeared in court to answer the charges of Disorderly Conduct, Resisting Arrest and Evading Arrest in the General Sessions Court of Bledsoe County.
38. On July 10, 2020, all criminal charges against Ms. Hembrook were dismissed by the General Sessions Court for Bledsoe County.

### **FIRST CLAIM FOR RELIEF**

#### **Violation of the Fourth Amendment – False Arrest (42 U.S.C. § 1983)**

39. Plaintiff repeats and re-alleges all paragraphs above, as if fully set forth herein.

40. On September 27, 2019, Trooper Seiber, without probable cause, falsely arrested Ms. Hembrook and transported her to the Bledsoe County Jail.
41. Trooper Seiber ignored the readily available exculpatory evidence which was provided to him during the initial traffic stop on September 27, 2019, and therefore lacked probable cause to arrest Ms. Hembrook.
42. Trooper Seiber knew or should have known that he lacked probable cause for any of these actions.
43. Trooper Seiber intended to and did confine Ms. Hembrook without her consent on September 27, 2019.

## **SECOND CLAIM FOR RELIEF**

### **Violation of the Fourth Amendment – False Arrest (42 U.S.C. § 1983)**

44. Plaintiff repeats and re-alleges all paragraphs above, as if fully set forth herein.
45. On March 6, 2020 Trooper Seiber, without probable cause, falsely arrested Ms. Hembrook for Disorderly Conduct, Evading Arrest, and Resisting Arrest.
46. Trooper Seiber knew or should have known that he lacked probable cause for any of these actions.
47. Trooper Seiber intended to and did confine Ms. Hembrook without her consent on March 6, 2020.

### **THIRD CLAIM FOR RELIEF**

#### **Violation of the Fourth Amendment – Malicious Prosecution (42 U.S.C. § 1983)**

48. Plaintiff repeats and realleges all paragraphs above, as if fully set forth herein.
49. Trooper Seiber ignored the readily available exculpatory evidence provided to him during the initial traffic stop on September 27, 2019, and therefore lacked probable cause to initiate criminal proceedings against Ms. Hembrook for Possession with Intent to Distribute/Sell/Manufacture Marijuana.
50. Trooper Seiber knew or should have known that he lacked probable cause.
51. Trooper Seiber knew or should have known that he made false statements regarding the substance found within Plaintiff's car.
52. Detective Seiber initiated criminal proceedings against Ms. Hembrook for possession of marijuana despite the masses of exculpatory evidence available to him prior to the arrest.
53. The charge was dismissed against Ms. Hembrook on July 10, 2020.  
**(Exhibit 4 – Certified Court Files; Exhibit 5 – Additional Certified Documents).**
54. Therefore, the criminal proceedings were favorably disposed.

## **FOURTH CLAIM FOR RELIEF**

### **Violation of the Fourth Amendment – Malicious Prosecution**

**(42 U.S.C. § 1983)**

55. Plaintiff repeats and re-alleges all paragraphs above, as if fully set forth herein.
56. Trooper Seiber knew or should have known that he made false statements to support the charges against Plaintiff on March 6, 2020 for Disorderly Conduct, Resisting Arrest, and Evading Arrest.
57. Trooper Seiber knew or should have known that no probable cause existed to initiate criminal proceedings against Ms. Hembrook for Disorderly Conduct, Resisting Arrest, and Evading Arrest.
58. Despite these facts, Trooper Seiber initiated criminal proceedings against Ms. Hembrook for Disorderly Conduct, Resisting Arrest, and Evading Arrest.
59. All charges against Ms. Hembrook were dismissed on July 10, 2020.  
**(Exhibits 4, 5).**
60. Therefore, the criminal proceedings were favorably disposed.

### **DAMAGES**

61. As a result of each and every of the Defendant's acts above alleged, the Plaintiff has suffered damages, including:
- a. Emotional distress;
  - b. Deprivation of constitutionally protected liberty interests;

- c. Deprivation of property;
  - d. Humiliation and damage to reputation;
  - e. Attorney's Fees;
  - f. Loss of enjoyment of life;
  - g. Loss of income.
- 62.** Because the actions described herein reflect evil motive and intent or a reckless indifference to the federally protected rights of the Plaintiff, an award of punitive damages is appropriate and necessary to deter similar wrongdoing by this defendant and others similarly situated.

WHEREFORE, the Plaintiff requests:

- I. That a jury of 12 persons be empaneled to try this case;
- II. A declaratory judgment that Defendant's conduct violated Plaintiff's' protected constitutional rights;
- III. Compensatory damages;
- IV. Punitive damages;
- V. Reasonable attorney's fees and litigation expenses;
- VI. Pre- and post-judgment interest;
- VII. Such other and general relief as the court deems just.
